TO: Middle Western Province Officers
Chapters of the Middle Western Province

The Province Polemarch has appointed me as Chairman of the Nominating Committee for the 80th Middle Western Province Council Meeting, April 18-21, 2002, in Kansas City, Missouri. Province Officers will be elected in accordance with Grand Chapter Rules and Regulations, and the Bylaws of the Middle Western Province. The committee will accept at least three (3) nominations for the office of Province Polemarch. Selection of the Province Polemarch from these nominations will be made by appointment of the Grand Polemarch.

Nominations for Alumni positions will be accepted for the following offices: Senior Province Vice Polemarch, Province Keeper of Records & Exchequer, and one (1) Member of the Province Board of Directors. Undergraduate Chapter members may be nominated for the following offices: Junior Province Vice Polemarch, Assistant Province Keeper of Records & Exchequer, Province Strategus, Province Lieutenant Strategus, and two (2) Members of the Province Board of Directors. Applications for the offices of Province Historian and Province Reporter will be accepted from Alumni and Undergraduate Chapter members.

Prospective candidates for office must complete the enclosed application and submit a current resumé. Undergraduate applicants must also submit a current transcript in order to certify a grade point average of at least 2.3 on a 4.0 scale. Incumbent Province Officers must contact the Province Keeper of Records and Exchequer to update their resumé if they wish to be included on the committee's slate. Candidates will be certified by the Nominating Committee in accordance with the Bylaws of the Middle Western Province, Article IV - Election of Province Officers:

- Section 2. Each candidate for office in the Province must submit a written application to the Province Nominating Committee signed by the Polemarch and/or Keeper of Records of his local Chapter. The application shall contain the following:
1. Financial status with local chapter and Middle Western Province.
 2. Chapter office(s) held.
 3. Elective and appointive office(s) held in the service of the Grand Chapter and the Middle Western Province.
 4. Current status of the member in terms of scholarship and suspensions or other disciplinary action by the fraternity or college, where applicable.
- Section 3. On-site applications for Province offices or positions shall be restricted to only those offices or positions for which no written applications have been received by the Province Nominating Committee at least fifteen (15) days prior to the Province Council Meeting.
- Section 4. No member shall be eligible for office who is under suspension or other disciplinary action by the fraternity or college, who is scholastically deficient with a cumulative grade point below 2.3 on a 4.0 scale or the equivalent thereof, who is financially delinquent with the fraternity at any administrative level, or who is not in attendance as a registered delegate at the Middle Western Province Council Meeting.
- Section 9. No member shall occupy more than one elective Province office or position.

Applications should be sent to me and must be **RECEIVED** no later than **April 4, 2002**, to be considered. The deadline for applications in Kansas City will be set by the Province Polemarch during the opening business session.
